# <u>Lake Management – Mark Jacobson</u>

Promoting Healthy Lakes:

### Aquatic Invasive Species Education:

There is a meeting regarding Aquatic Invasive Species on Wednesday, June 14<sup>th</sup>. Lake Management Committee is trying to get someone to come educate residence of Lake Wapogasset/Bear Trap. Steve Scheiffer (Fresh Water Biology Teacher) may be available in August.

Through the Looking Glass: A Field Guide to Aquatic Plants – Educational Book provided by UW Stevens Point. Cost – 11 books for \$230. Recommended to purchase enough books for all Trustees. Trustees can share with members interested in learning about different plants in lake – good plants and invasive species. Another recommendation is to give to those members who attend the Invasive Species class in August. Motion was made to purchase 33 books (Total of \$660)/Seconded, Approved. Rick Rickard Bazille will give Doug Drake information to purchase books.

There were questions regarding the large amounts of Algae/Moss seen in the lake. Unsure of why the lake has so much algae/moss this year.

#### Harvester:

64 Loads of weeds were harvested as of last week. Currently the harvester is in the Bear Trap area. They are continuing the southern loop and expect to be on the west side of Lake Wapogasset in the near future. The work staff has increased to 6. The YMCA camp loading area is working fine. Many thanks to them for letting us use the area. Steve Schieffer has done more mapping and we should have the data at our next meeting. The equipment is working as expected. No issues. Weather (wind and rain) affect the operation more than expected. Recently, the truck got stuck in a farmer's field when they were unloading the weeds. (Unusual things happen!) Be patient. It is a big area and only one harvester.

There were concerns about how many weeds were coming to the lakeshore. It will be brought to the attention of the Sanitary District. Most of the weeds should be going into the conveyor but some of the operators are new and still learning.

Harvester Naming Contest – Looking to name the Harvester. Any name ideas should be submitted by August 1<sup>st</sup>.

### **Lake Monitoring – Lee Rickard**

#### Zebra Mussels:

Found a place to purchase Zebra Mussel Samplers. Cost: \$12/each + tax and shipping. Total cost for 12 is \$167.50. Mark Jacobson and Lee Rickard Rick Bazille will install and monitor. Polk County Land and Water has put us in touch with Fish and Wildlife (Dan Wedan). He will meet with us to instruct us on placement and monitoring. Information was emailed to Executive Committee and Lake Monitoring committee for opinions – Of those who responded, all were favorable.

# Clean Boats/Clean Waters:

Started Memorial Day Weekend – Handing out Ice Packs with "Stop Aquatic Hitchhiking" information. Sign at Waterside was down. Replacement is needed. Someone suggested having "Clean In, Clean Out" written on asphalt at boat landing. Will look into.

#### Swim Platform:

It was mentioned some swim platforms are out farther than usual. Unsure of Legal Limits. Info is on DNR website. However, lakeshore owners need to know property stops at shoreline which means swim platforms and docks are public property.
