Motion/second to approve the Treasurer's report for May 2016. Motion approved. President Report by Marty Noonan

Marty and Doug Drake met with Kathy Mortenson to discuss the future of the Lake Scene. Marty provided a detailed history of the Lake Scene and complimented and thanked Kathy and other newsletter contributors for their years of commitment and dedication. It was make very clear the Lake Scene is an important publication and unanimously agreed the desire to have it continue. Significant discussion took place and the goal for the balance of the summer 2016 is to have Kathy prepare and publish the Lake Scene for July, August and possibly September provided Kathy seeks volunteer commitments from others, specifically the Phantom Fisherman. For future, and in order to keep the Lake Scene going, Kathy will require the support of volunteers to write articles, provide information, assemble and distribute the Lake Scene. Jim Anderson, Communication Committee Chair will assemble a group of volunteers to help with this effort. Motion/second to approve the Lake Association pay the printing costs of July's issue. Motion approved.

Committee Reports

<u>Lake Management.</u> Mark Jacobson explained Wisconsin's DNR Healthy Lakes Program which provides grant money to promote healthy lakes and prevent lake pollution. 25 projects are available and funding is \$1,000 per project. Barry Eklund reported weed harvesting is in process as well as the repair of the GPS which navigates the harvester **Lake Monitoring.**

Lee Rickard indicated the lake temperatures of both Wapo and Beartrap are greater than last year which may result in "greener" lakes in the coming weeks. Lee completed Sechi Disc readings which are available on the DNR web-site. Dave Nelson suggested inviting Steve Schiefer, Sanitary District Biologist/Consultant meet with the Lake Association to identify invasive weeds.

Clean Boat/Clean Water. Rick Bazille reported the Garfield Park boat landing was extremely busy over Memorial weekend. Two DNR sponsored events include the Drain Campaign on June 10-11 to educate fisherman to drain livewells and other equipment before leaving the boat landing (freezer packs given away for fish coolers), and the Landing Blitz June 30 – July 3rd to educate boaters on measures to prevent the spread of aquatic species (towels will be given away for boaters to clean and dry their boats). The final CBCW cost in 2015 for the Lake Association was \$376.71. The DNR did not provide grant funding in 2016 therefore the CBCW program will be funded by the Lake Association and Sanitary District.

Neighborhood Watch. Jerry Tessman indicated Neighborhood Watch signs will be available in July and requested everyone report signs in need of replacement, and identify/recommend new sign locations. Rick Bazille and Martha Funke have volunteered to replace or install new signs.
