First Vice President Dave Nelson started the meeting at 8:00 a.m.

### Secretary's Report by Beth Holmgren

Minutes: Motion/second to approve the Secretary's minutes for September 12, 2015 with one change in the Lake Management Committee Report; the total cost of the weed harvester is \$178,450, not \$115,000. Motion approved.

Motion/second to approve the Treasurer's report for January – April 2016. Motion approved.

# First Vice President Report by Dave Nelson

Dave introduced Jeffrey Hahn, Polk County Sheriff who discussed new boating rules and regulations and provided "the Handbook of Wisconsin Boating Laws and Responsibilities". Operation Dry Water enforcing DUI laws will occur on WAPO/BT on June 24-26, 2016. DNR Game Warden, Peter Wetzel is actively monitoring and enforcing lake requirements. The old lake patrol boat was sold for \$19,000 and 50% was refunded to Big Lake, Church Pine, Round Lake District and 50% goes back to the WAPO/BT Lake Association. Kathy Mortenson is no longer preparing and publishing the Lake Scene, therefore the Lake Association needs to determine how to replace it with another type of newsletter/communication tool for lake residents. Dave recommends board member(s) and the new President meet with Kathy to discuss her decision. - Barry Eklund announced the Weed Harvester is here and training for the Sanitary District operators is in progress. Curly Leaf pond weed cutting will begin in a few weeks and Barry provided a lake map identifying where cutting will occur. Cutting duration is 4-6 weeks once a year and results can be expected in 3-5 years. Barry emphasized this project is to improve the quality of the lake. Motion/seconded to approve paying Paperworx for the cost of the weed harvester sign. Motion approved
- The Rescue Airboat purchase by the Fire Department was postponed until they have enough money to purchase it. The Lake Association previously approved donating \$5,000 in 2015 provided it was purchased by 5/31/16, therefore the deadline has lapsed. Motion/seconded to let the deadline lapse requiring the Fire Department to come back to the Lake Association to request future funding. Motion approved
