September 10, 2016

Meeting began at 8:00 a.m.

Welcome and introduction of guests

1. Secretary's Report

- a. No report today, as Michelle is out of town
- b. Minutes will be sent for review via email

2. Treasurers Report

- a. Financials were sent by Doug in advance of meeting for review
- b. Airboat grant of \$5000 was given to the Fire Dept. They have reported that no deposit has been made on the boat as of yet due to a price increase.
- c. 460 paid members

3. Presidents Report- Marty Noonan

- a. Mike Masterson President of the Conservancy reported that the conservation water retention program on the Freitag farm has been completed. Thanks to all who donated funds! There is ~ \$16K left over, will go towards the next initiatives, the Christenson farm and Friday creek areas. It was also noted that agriculture run off is the biggest issue causing nitrates going into the lake and we need to keep working on each individual residents properties as well.
- b. Volunteer recognition dinner tonight: Peter Seidl and Joe and Vicki Ziglinski are this year's recipients. Marty also wanted to recognize all volunteers and the appreciation for everyone's work on the Lake Association

Committee Reports:

Lake Management – Mark Jacobson

Healthy lakes initiatives are being reviewed and in progress, The YMCA camp, Eagle Crest, and several other residents are putting plans together to apply for a grant to enhance their waterfront areas . Deadline for the grant is Feb 1, with an on-line form that needs to be completed. \$1000 maximum per individual, \$25K for the entire grant. The cost split will be 75% DNR /25% property owner up to the maximum. There are several options; 1. Fish Sticks (trees in the water tied together and cabled for fish habitat). 2. Plantings and rain gardens need to 350 Square feet by 10 ft. wide. 3. Diversion of the water run off elsewhere, however this is not a good option on our lake. 4. Rock infiltration, which needs to be 6 ft. deep. Suggestion that trustees identify anyone in the area that has run off and encourage them to participate. This information will be posted on the Lake Association website. Discussion around needing a resolution by the Lake association to proceed with this grant, motion made, seconded and unanimously approved. Alex Smith is the DNR contact for us. Topography photos of the lake are housed at the Sanitary District, and provides an overview of the "hotspots" and was recommended to be reviewed to help identify areas.

The Lake Harvester is in storage (inside) at the sanitary district after a very successful year. It was a learning experience this year and noted that weather is a key factor in growth of the Curly Leaf. We will be increasing the crew next year to 6 people; 2 full crews and 1 alternate crew working 2 six hour shifts. Lake Monitoring – Lee Rickard

Thanks to all those that helped with the monitoring this year. Last sample was taken in August and results were noted in last Lake Scene. The Blue-green Algae arrived in the last weeks driven by the warm temps and heavy rains. A reminder and caution to keep animals away as it is very toxic.

Clean Boats/Clean Waters - no update

We have reduced our order and expect to have additional signs available in 6-8 weeks.
